Please, accept my personal invitation to join SWACJ at its October 4-6, 2007 annual meeting in Corpus Christi, Texas. We will be at the Omni Marina Hotel on the bay near downtown Corpus Christi. Information about the hotel and making reservations is available in this newsletter and on the SWACJ web-site. Use the link to the Omni's landing page created especially for us as the easiest way to make reservations. Should you choose to call or e-mail the Omni, please be sure to use the **group code** cited on the hotel information page. Remember our group rate is good for two days before and after the meeting days. Corpus Christi is visitor friendly and we could use your money; come have fun and spend lots of it. If you are flying in, the Omni provides free shuttle service to and from the airport.

As your resident tourist guide, I can provide reasonable assurance the bay and gulf waters will still be warm enough for beach and water activities. The city is home to the *Texas State Aquarium*, *The Lexington Aircraft Carrier Museum*, the *Museum of History and Science*, site of the Columbus ship replicas, the *Art Museum of South Texas*, with its recent additional building, the *Museum of Oriental Cultures*, and much more.

The President's Reception on Thursday evening will be held on the Captain's Flagship during a tour of the Port of Corpus Christi and Corpus Christi Bay. The Flagship will leave the marina, a short walk from the hotel, on schedule so be sure to check the preliminary program for the departure time. Treasurer's Report

Dear Members:

As of May 1, 2007 we have \$10,095.27 in savings and \$11,077.23 in checking.

We had an outstanding turnout for the annual meeting in Fort Worth and a great meeting during ACJS. A part of these meetings was the discussion of several items by the officers and members in terms of finances. Among the items were:

Clarity on payments

During each year's annual meeting, every effort is taken to match payments with the appropriate individuals for whom the payments are intended. A continuing hurdle has been that often, payments are received with little information in the memo section clearly stating who the payment is for. During the 2007 annual meeting season, payments received without sufficient accompanying data will be refused. During 2006, such payments created several hundred dollars worth of discrepancy we needed to resolve.

New forms

During the mid-winter meeting in Seattle, several recommendations were made to make the annual meeting and membership forms more effective. The new process for annual meeting registration will involve sending the registration form and payment to the *treasurer* and sending all abstracts and requests to serve on the program to the *program organizer*. The purpose of this change is to streamline communications for the program effort. Additionally, a membership option will most likely not be listed on the registration form. Annual meeting attendees wanting to pay for registration and membership simultaneously, can simply write one check to cover both, but must complete each of the two forms, both of which will be available on the SWACJ website.

Credit card processing

Based on the increasing number of requests for credit card processing, an effort will be made to make this option available in Corpus Christi for the 2007 meeting.

It is a pleasure to serve as your treasurer and be part of SWACJ's growth.

**Minutes of the Mid-Winter Meeting,  
Seattle, Washington,  
Academy of Criminal Justice Sciences Conference  
March 13, 2007**

Tracy Andrus, 2d Vice President graciously took minutes in the absence of the secretary. Many thanks, Tracy.

Minutes:

- Welcome by Will Oliver
- Bob Taylor from University of North Texas thanked SWACJ for the contributions made in behalf of Tory Caeti. Bob also forwarded the thanks of Tory's family for the many expressions of sympathy and support given by his friends in SWACJ.
- Chip and David read the minutes of the previous meeting; the minutes were approved.
- David reported \$10,111.82 in the savings account and \$11,077.23 in the checking account as of 3/3/07.
- There were 176 individual participants in attendance at the SWACJ conference in Ft. Worth. Gross receipts for that meeting were \$12, 775.00.
- At the fall 2006 annual meeting SWACJ received \$260.00 from sources that were not attributable to any individual or college.
- Expenses for the fall 2006 annual meeting were \$8917.92 leaving a \$4117.08 profit after all meeting related expenses were paid.
- David suggested that in the future, payment should be received from participants before they be allowed to participate at the SWACJ annual meeting.
- David also suggested a requirement all meeting participant fill out an additional form that would include the information regarding the sessions they desire to participate in and that this information be sent directly to the individual organizing the program. The first page of this form would include sections identifying whether or not the participant was student or faculty and the amount of fees being paid.
- David also discussed the feasibility of allowing participants to pay by credit card/Pay Pal, etc.
- The membership present discussed the possibility of offering a lifetime membership for SWACJ. This discussion was taken under advisement.
- Phillip Rhoades discussed items concerning the SWACJ 2008 Annual Meeting in Corpus Christi. Two bids for the main reception were discussed:
  - The Captain's Flagship @ \$1600.00 + \$250.00. The boat would leave dock at 6PM and return at 9PM.
  - The Texas State Aquarium @ \$2700.00 + \$5.00 per person
- The group voted to accept the bid from the Captain's Flagship.
- The fall conference will be held October 4, 5, and 6<sup>th</sup> at the Omni Hotel in Corpus Christi. Rooms are \$85.00 for 1-2 persons and \$115.00 for 3-4 persons.
- Tracy Andrus gave the report on the out of state conference to be held in 2008. The group decided on Little Rock, Arkansas as the location.
- Tracy Andrus will be responsible for getting quotes for accommodations and organizing this event.
- Editors' Report. The group agreed to utilize the printed version of the SWACJ Journal because it was more prestigious than the online journal.
- Copies of the most recent journal were distributed to those in attendance.
- There was no old business.
- Refreshments were served and enjoyed by all present.
- The student presentation scholarships were discussed and it was agreed the scholarships would be given to two undergraduate students but it was stipulated they could not be among the winners of the paper competition.
- Per requirements of the constitution, three persons were chosen to sit on the Audit Committee. The Committee will be responsible for auditing and inspecting the records of SWACJ. They will each serve a three year term.
  - The three members of the Audit Committee are: Christine Nix, Lorie Rubenser, and Janice Ahmad.
- ACJS will meet in Cincinnati in 2008. Our own Wes Johnson will become president in 2009.

**Who is Eligible?** Undergraduate students currently enrolled (and those who will be enrolled September 2007) in a university, college, junior college or community college within the **Texas Association of Criminal Justice Educators** of the Southwestern Association of Criminal Justice.

**Presentation of submitted papers:** Students **are required** to attend the Southwestern Association of Criminal Justice annual conference and present their papers to be eligible for the scholarships.

**Awards:** Pay for the top 2 student's registration fee for the Southwestern Association of Criminal Justice annual conference.

**Criteria:**

1. The paper must be authored by student(s) only. No Faculty/student joint papers will be considered.
2. The paper must be an original work.
3. Undergraduate students currently enrolled (and those who will be enrolled September 2007) in a university, college, junior college or community college within the **Texas Association of Criminal Justice Educators** of the Southwestern Association of Criminal Justice.
4. The paper **must not** be a winner in the SWACJ Student Paper Competition.
5. Three copies of each paper must be submitted before **September 17, 2007** to: the current president of the Texas Section, *Ed Schauer, Texas Juvenile Crime Prevention Center, Prairie View A&M University, PO Box 4017, Prairie View, TX 77446-4017*. Papers received after the deadline will not receive consideration.
6. The paper must meet standard publication formats as established at the student's home university or college.
7. The paper will be judged at the conference after the luncheon by a panel of 3. The panel will be appointed by the current president of the Texas Association of Criminal Justice Educators.
8. The title page of the paper should include the student's full name and address, school affiliation, and status as either graduate or undergraduate.



# ICPSR Summer Program in Quantitative Methods of Social Science Research

## Workshop on Developing Proposals for International Criminological Research

This three-and-a-half-day workshop, sponsored by the National Institute of Justice (NIJ) and held at the University of Michigan, will help new researchers develop and refine skills needed to develop successful proposals for international criminological research. The course will cover developing the basics of the proposal, designing doable and fundable research, creating an integrated proposal and identifying appropriate research methods. Researchers will gain an understanding of the NIJ application procedures. The intensive workshop will also offer opportunities for hands-on activities, including mock peer reviews and small group assignments.

This rigorous workshop is designed for applicants who have not previously received a federal research grant. Enrollment in the course is limited. The two-step application process is intended to ensure that participants acquire the skills to write a successful proposal and ensure that adequate feedback is provided to the participants.

First, applicants must submit a vita and cover letter summarizing research interests, objectives for participating, and experience. Individuals applying for this course should check the Competitive Three to Five-Day box on the ICPSR Summer Program application form. These application materials are due by June 1, 2007.

Upon selection, participants will be asked to develop a 15-page research proposal and submit it to ICPSR by July 30, 2007. This proposal will be peer reviewed in two separate settings and will be used as a foundation during the class. The National Institute of Justice will provide students a stipend of \$1,125.
