President's Message

Howdy!

I hope that everyone is having a restful, productive, and safe summer. I know that—among other things—the COVID-19 pandemic has been exceptionally taxing on all of us, our families, our students, and society. Fingers crossed, we are to a point where we can begin to gather with friends, colleagues, and students again.

I know that I, for one, am looking forward to our conference in Austin on October 19-21. The Executive Board is working on bringing you an informative and worthwhile conference in one of the greatest cities in the country. Although to be fair, almost anything is an improvement relative to Grand Forks in October. It has snowed here the last two years, and quite frankly, that is just too early in the year for me to see snow.

The conference will be held at the [Austin Southpark Hotel](#), which is now converted into a Marriott property. The new team at the hotel has been delightful to work with, and I am optimistic about the event. The room rate—for up to 4 occupants per room—is \$159 per night. To get this rate, you must [use this link to the reservation site](#). Two reasons it is important to book your rooms directly through this link. First, SWACJ signed a contract with the

hotel guaranteeing a certain number of room nights in exchange for the meeting space. If we do not meet the minimum number of rooms, SWACJ will have to pay a substantial penalty to the hotel—beyond the other expenses incurred to put on the conference. Second, last year, the City of Austin was again selected to host an **F-1 Race** the weekend after our conference! This is certainly an exciting prospect for the end of the conference, but it also means people are competing for hotel rooms. Our contacts at the hotel said that the going rate for rooms at the conference hotel would be substantially more than we are paying for them (at least \$600 per night). That being said, it will likely be difficult to find a better rate in Austin at that time! I would encourage you to book your rooms early and if you are so inclined to stay for the race over the weekend, feel free to use our rate! I did this already and am planning to try and find a venue to watch the race. If anyone is interested in joining, please [email me](#), and I am glad to add you to the planning for that as well. You can find more information about the conference in the updates from other members of the Executive Board below. We will also generate a separate information sheet that will be sent out in the coming days.

Finally, over the last year, SWACJ as an organization has been quietly toiling away in the background, trying to do the things that keep the organization going and growing. We as an Executive Board have not been as good at communicating with our members as we should have been, and I will take full responsibility for the prolonged silence, and I apologize. The Executive Board has had several personal and professional challenges that required our attention this year. Additionally, there have been some challenges for the organization that has also required our immediate attention. Specifically, Scott Jacques stepped down as the Editor of *The Qualitative Journal of Criminal Justice and Criminology*, and Whitney Gass stepped down as 2nd-Vice President. At the meeting, we will be soliciting nominations to fill several seats on the Executive Board starting at the General Business meeting at the conference. Now is a great opportunity for folks to get involved with SWACJ and contribute their talents and time to further developing the organization.
