The late 1800's was a time of great fraternalism; many college fraternities had their founding during this period, social clubs expanded, and fraternal orders for men experienced explosive growth. Even following the devastation of the American Civil War, men still made financial provision to be joiners. Albert Pike, a leading member in Freemasonry, wrote of his own fraternity that they were floundering for want of relevancy. In fact, Pike argued that Freemasonry had lost its relevancy hundreds of years before and was just floundering through existence. He went on to lay the same issue on the other organizations that

were around in his day.

I recently participated in a conference of leaders in Freemasonry where this "seeking relevancy" was the main issue. As I listened, I was reminded of similar discussions in other organizations, seems everyone is asking, "How do we become relevant?" This is true of this organization as well; we keep asking how we can become relevant in our region.

Remember, this is a regional organization, covering Arizona, Arkansas, Colorado, New Mexico, Oklahoma, and Texas. Arizona has had no participation in a considerable time, Colorado has very little, Oklahoma seems to only participate when we have a session there, New Mexico has little participation, Arkansas has little more than Oklahoma and in the grand scheme of things, and we have to be honest that Texas has limited participation. This is true in a time of great expansions in Criminal Justice programs in higher education, our conferences should be consistently above a 250 participant attendance level, and we are not.

In response, we looked at other regional associations to determine if people in ours were choosing to go elsewhere. We found little evidence of this being the case, although there are instances. Conversely, we have participation from other regions as well. We continue to review our own participation, and try to understand how we can encourage more Criminal Justice academics to participate.

One suggestion that bounces around fairly consistently is that we should become the interface for Criminal Justice academia to meet practitioner. This intrigues me, but the question is whether it does the same for others? As a former practitioner, now academic, I appreciate the need for this interface, and as I move away from my practitioner retirement date, I know I have to reach out more to maintain current knowledge with the field application of Criminal Justice.

As an academic, I believe that such an opportunity to have a formal interface portal has potential to benefit our students. The information we gather would allow us to take current field knowledge back to the classroom; open the doors for increased guest lectures in the classroom; promote internship opportunities; build bridges to assist our graduates in obtaining employment, which is increasingly become an issue in academic assessment. The portal would work both ways, by allowing practitioners to a ready source of theory; promote "think tanks" to helping problem solving; and gain assistance in evaluating programs and planning.

As we move forward in planning the 2014 SWACJ Conference, I would appreciate some dialogue about whether we are interested in serving as a portal for the interface between the Criminal Justice academic and practitioner. Have an idea? Please contact me directly to share your thoughts.

Annual SWACJ Undergraduate Student Criminal Justice Quiz Bowl (2013)

Team Composition: A team will consist of two to four members. Team members must be registered for the Annual Meeting as students. Teams will be registered on a first to register, first to qualify basis. A maximum of 8 teams will be allowed to participate. Each college or university participating in the SWACJ Annual Meeting may enter *one* team.

Teams must pre-register by contacting **Dr. George Franks** (franksgr@sfasu.edu) no later than midnight, **September 15**, 2013. Teams do not have to list exact members to pre-register for the Quiz Bowl – simply indicate that a team from a particular program will participate. Exact members must be indicated at conference check in where registration for the conference will be verified.

Relays (**Rounds**): There will be two relays plus the championship round. For the two relays, teams will be divided as evenly as possible. Placement/assignment of the teams for relays will be done randomly. The winning team from each relay will then compete for the championship. The two teams in the championship will not carry any previous points (or standing) from the first relays. Thus, both teams in the championship will start with zero points. The team with the most points in the championship round will receive the first prize (\$250). The second prize winners will receive a cash award (\$150). **Prize money** for first and second place will be given to the faculty advisor for the winning teams to be used as they determine.

Teams in the first relays will be quizzed from the categories of:

- 1. **Introduction to Criminal Justice** Five questions commonly found in intro CJ textbooks.
- 2. **Courts and Criminal Procedure** Five questions from courts and/or criminal procedure textbooks.
- 3. **Women and Minorities** Five questions relating to the impact of the CJ system on Women and Minorities
- 4. **Criminological Theory** Five questions about theories of criminality.

In the event of a tie, the category will be *potpourri* for best of two out of three questions.

Teams in the championship relay will compete for first place. They will be quizzed from:

- 1. Law of Arrest, Search, and Seizure Five questions.
- 2. **Major Supreme Court Decisions** Five questions.

In the event of a tie, the category will be *potpourri* for the best of two out of three questions. In all relays, Team Captains will have buzzers to 'buzz-in' when their team is ready with a correct answer. The Team that buzzes in first will be given the first opportunity to answer. Should that team give an Incorrect response; the next team to buzz in will be given opportunity to answer, and so on down the line.

Good sportsmanship will be observed at all times by all participants and spectators. Individual participants who engage in rude, disrespectful, or unsportsmanlike behavior may be disqualified. Participants must keep cell phones out of sight during the Bowl. Spectators who engage in rude, disrespectful, or unsportsmanlike behavior may be asked to leave the event. This includes attempting to convey answers to any person in any manner.

2013 Poster Session Southwestern Association of Criminal Justice

The *Poster session* offers the opportunity to participate in an innovative, progressive, interactive presentation of your research guaranteed to reach a wider audience than traditional panel presentations.

The poster session is a collection of visual displays of research that encourages informal interaction between authors and attendees. The primary author of a Poster presentation must be in attendance and committed to stay throughout the presentation.

How to be a Poster Presenter:

Submit presentation topics via the **Abstract and Panel Participation Form**. Upon acceptance, prepare a visual presentation for your paper, and bring it to San Antonio.

Set up your presentation in your assigned spot 30 minutes BEFORE the poster sessions begins and remain at your spot for the full time the poster session is scheduled.

The poster presentation

A poster consists of two components. First, it is a visual display of research and secondly, it involves interaction with the audience. The research is usually PowerPoint slides or some other computer software. Then the slides are printed and placed on a poster stands provided by SWACJ. The visual display includes text, tables, graphs etc. Some people choose to have their posters printed professionally or laminated; this is a personal preference but is not required. The second component of the poster research requires that the author(s) interact with the audience during the allotted session time. Conference participants browse the displayed visual presentations of research and have an opportunity to inquire about the research.

Anyone interested in presenting research may do so by submitting an **Abstract and Panel Participation** form no later than **midnight 8 September 2013**.

No one can present* more than one poster presentation at the conference. However, participants may be a co-author of research with other co-authors who will present the additional research. Each poster presentation must have an author present to interact during the duration of poster session. (*No person's name may appear more than twice as author or presenter).

No unattended presentations. At least one presenter is required to stand by your poster for the entire session. If there is more than one author, it is acceptable to alternate or split up times with your coauthor(s). If your research is accepted, we will expect someone to be available to present it in your place. Please plan and have a backup person who can present the research on your behalf if you cannot attend the conference.

JUDGES

Judges must be active within SWACJ and will be selected from the updated membership list. Judges may or may not elect to award all of the prizes available depending on the number of entrants and quality of the papers.

ENTRY RULES AND REGULATIONS:

- 1. Student(s) must author the paper; no faculty/student joint papers will be considered.
- 2. The paper must be an original work; it may be especially prepared for the 2013 SWACJ annual meeting, or it may be a revision of a paper prepared for coursework at the student's home university or college.
- 3. The paper must be submitted electronically to: jblair@southtexascollege.edu
- 4. To be considered for competition, entries must be received by midnight, **September 8**, 2013.
- 5. The paper must meet standard publication formats as established at the student's home university
 - or college.
- 6. The title page of the paper should include the student's full name and address, school affiliation and status as either graduate or undergraduate.
- 7. The author's name and affiliation **should not** appear on any other page of the submitted paper.

PRESENTATION OF SUBMITTED PAPERS:

Felix Fabian Founder's Award Nomination Criteria

Awarded to SWACJ members who are deemed deserving of special recognition for their outstanding contribution to SWACJ and the profession.

Prior recipients of the Felix Fabian Founder's Award are not eligible for nomination.

Selection Criteria:

Active member in good standing of SWACJ for at least five (5) consecutive years.

Active involvement in criminal justice education and research for the preceding five (5) years.

Through service activities, has made a substantial contribution to SWACJ and to the discipline of criminal justice.

Nominations for the Felix Fabian Founder's Award may be made only by current SWACJ members.

The deadline for nominations is **September 15, 2013.**

Nominations may be submitted by any current SWACJ member. The nomination should include the following information: (a) a brief summary of the nominee's contributions in accordance with the award criteria, and (b) an explanation of the significance of these contributions. Submission of supporting materials with nominations is encouraged but not required.

As I write this newsletter entry for the Spring of 2013 SWACJ Newsletter, I am in the throes of putting together the first issue of our new journal –

Journal of Qualitative Criminal Justice & Criminology (JQCJC). As you can imagine, my letter will be brief (well, brief for an academic).

That said, I think you will be happy with the way the new journal came together. As you remember, we lost our editor, and I was contacted by the SWACJ President (George Eichenberg at the time) to see if I had any ideas on what to do with the journal. As the SWACJ board originally created the journal with the goal of having it become a high quality national and internationally prestigious journal, there was some belief that the original journal did not meet this goal for it had become too regionally focused. It just so happen that I had an idea because of some of the issues I was facing in getting a qualitative course launched in the Ph.D. program at Sam Houston. Thus, the need from SWACJ and my idea resulted in the Association's new journal.

On Monday April 15, 2013, the first issue of volume one of the *Journal of Qualitative Criminal Justice & Criminology (JQCJC)* was made available on our new dedicated website for the journal www.jqcjc.org or by following the link on our homepage www.swacj.org The journal is sponsored by SWACJ and supported by Sam Houston State University and will be published twice a year, April 15 and October 15.

If you look at the first issue you will note that many of the leading qualitative scholars have joined the editorial board. In addition, many of the leading qualitative scholars have authored papers for the first issue, and although not acknowledged in the first issue, many of the leading qualitative scholars have also offered their time in the conduct of peer reviews for the journal (the complete list of reviewers will appear in issue 2).

As the SWACJ journal editor, I also should note that I attended both ASC and ACJS and served on a roundtable at both conferences which were formed to discuss the journal. The one at ASC was chaired by Patrick Carr and the one at ACJS was chaired by Dean Dabney. I also passed out flyers at both conferences, and there was much buzz about the new journal (both positive and negative!).

I have been very pleased with the number of submissions to the journal. Since opening up submissions in May of 2012, I have received 52 articles, rejected 35, and have accepted 7. The rest are currently under review. Six of the seven articles were published in the first issue of the journal on April 15, along with four book reviews and what we hope will be a permanent feature

– a historical book review – covering a seminal book in qualitative research that may be overlooked today.

While I think the new journal is off to a great start and looks to be a successful endeavor, as the saying goes, "the proof is in the pudding" and all of you will be the judge of your new journal. I am always willing to listen to feedback, positive and negative, so please, if you have any input on the journal, please let me know. Finally, I hope you all will consider sending along your qualitative research for the new journal.
