**Overview - Business Luncheon**

October 8<sup>th</sup>, 2010

The North Little Rock Police Department Bomb Retrieval Unit provided a demonstration.

Dr. David Montague, SWACJ President, presented Candace Greenlee a gift card for years of dedicated service to the University of Arkansas-Little Rock and SWACJ. At the time of the conference, Candace and husband were awaiting the birth of their first child. Candace will be a stay at home mom for a while.

Dr. Montague introduced the keynote speaker, Ron Angel, the Director of Youth Services - Arkansas. Dr. Montague stated, "SWACJ represents something unique through the different aspects of criminal justice as Region IV of ACJS. Educators from the field make up ACJS. Ron Angel embodies the theme for the 2010 SWACJ conference, "Theory to Practice". Ron taught police officers for many years".

Mr. Ron Angel said, "The field of law enforcement is more intricate now than in the past. In the 1970's the military would pick the biggest and meanest guy to be in the military police. Now law enforcement has to work smarter and be more knowledgeable of the law. I am a graduate of UALR, attended school at night and worked during the day. Dr. Chastain, my favorite professor, knew how to engage and make law enforcement think."

Mr. Angel continued, “The importance of education is respect and honor cannot be taught. I shared the knowledge gained in class with the law enforcement officers I trained. After retirement, I applied for the Director of Youth Services. It is not an easy profession. There are many critics. Prior to becoming the Director of Youth Services, the length of survival for a Director was three years. In the prior ten years, there had been a succession of nine directors. Youth services work together with UALR to help the youth of Arkansas and the impact is important. In the past five years juvenile recidivism has been reduced by 28.2%. Recidivism within a three-year period for a probation violation, another committed crime results in return to Youth Services, and a subsequent crime the outcome for juveniles is corrections.”

“Reading comprehension for Arkansas youth is at a fifth grade level, IQ in the seventies, and math at a sixth grade level. Fifteen percent of the youth have no biological parent in the home and eleven percent subjected to sexual abuse in the home before the age of ten. Ninety-one percent experience mental health problems, fifty four percent use drugs, and thirty one percent abuse alcohol. Ten percent of the youth are sex offenders, though some are sexually reactive. These kids do not have a chance and need understanding. Once the average daily attendance is complete for the year – kids are kicked out of school. The month of March is the benchmark in education and kids are put out of school to ensure test scores do not go down. Fifty two percent of African Americans kids are committed. Kids are committed for two weeks in the drug ward where they learn to adapt. Kids like being committed due to structure. They do not want to return to the toxic environment of home.” Mr. Angel ended by asking, “What is the effect of education? It will and does help. There are 400 million in correctional facilities and 54 million juvenile delinquents are in rehabilitation. The real solution is with the five and six year olds who are not going to school.”

On behalf of SWACJ, Dr. Montague presented a plaque of appreciation Mr. Angel. Dr. Lisa Hutchinson, UALR, who works closely with youth services and Mr. Angel, presented him with a personal \$100 gift certificate.

Dr. George Eichenberg, 1<sup>st</sup> VP announced the student quiz bowl would begin at 3 PM. Lawtech provided a different format with the questions and answers on PowerPoint and buzzers for student responses.

The luncheon was adjourned.

### **October 8<sup>th</sup>, 2010 - SWACJ Business Meeting**

Dr. David Montague, called the meeting to order and stated (paraphrased), “It was good to see members’ dedication in addressing the theme of “From Theory to Practice”. SWACJ is trying to keep in style with ACJS our parent organization. Why mention Theory to Practice? It better addresses the multi discipline criminal justice issues. As educators, advocacy maximizes relationships similar to those talked about by Ron Angel, the keynote speaker. Many members served in a professional capacity prior to becoming educators”.

Dr. Montague spoke about a three part temporal crime theory.

- 1) Home - the past and the present are always relevant in addressing the crime problems of the present.

- 2) Public policy perspective- relevant policy stakeholders need to take a position.
- 3) Connection of theory to practice – it is how we learn from our past and convince stakeholders to assist with needing funding.

Dr. Montague continued with a call for members to continue working as an organization and noted he had served in every capacity of SWACJ with the exception of secretary and regional trustee.

Dr. Montague expressed his appreciation to the officers, the members for their support, and the students for their participation. Stakeholders were commended for supporting the SWACJ region and ACJS.

### Executive Board reports

**1<sup>st</sup> Vice President - Dr. George Eichenberg** (Tarleton State University) reported the proposed date for the 2011 SWACJ annual meeting is 29-30 Sept to 1 Oct. The conference site is College Station. A first site visit revealed a lot to offer and Texas A&M is the parent campus to Tarleton State University.

Dr. Eichenberg provided several handouts related to College Station and the Hilton Hotel – proposed conference hotel. The Hilton is a true convention center and tentatively offered a rate of \$93 a night – single or double occupancy. There are a number of deals on the table at the Hilton.

The Texas Engineer Extension Service (TEEEKS) is partnering with Tarleton State University and with a 100 acres dedicated to a disaster village (Oklahoma City & World Trade Center bombings) for First Responder training. The local forensic science club may be available to host an undergraduate team crime scene search competition.

A motion was made to enter into a formal negotiation with the Hilton as the conference center for the SWACJ 2011 annual meeting. The motion received a second. A call for votes on the motion passed with none opposed and carried authorizing Dr. Eichenberg to negotiate the Hilton Hotel.

**2<sup>nd</sup> Vice President – Lorie Rubenser** (Sul Ross State University) reported the results of the student papers competition. Dr. Rubenser was assisted by Dr. Will Oliver and Vidisha Barua reading the student papers. Five graduate and no undergraduate papers were submitted. The second place prize of \$150 was awarded to Taylor Oxley of UALR. First place prize of \$250 was awarded to Valley Mendez of UT-San Antonio.

Dr. Rubenser announced the special Conference Edition of the Journal would accept papers presented at the 2010 Conference. As the editor, Dr. Rubenser extended the submission deadline to midnight 13 Oct 2010. Additionally, an invitation was extended to Valley Mendez, winner of the student paper competition, to submit to the special edition.

**Treasurer's report – Dr. Rob Worley** (Texas A&M University-Central Texas) stated the account started with \$13,433.01, with outstanding checks amounting to \$500.00, \$3930.00 in

payments received, and \$9516.95 in hotel expenses. Quiz bowl payments – 1<sup>st</sup> place \$250 to Wiley College sponsored by LawTech and SWACJ sponsored 2<sup>nd</sup> place to Prairie View A&M.

The SWACJ bank balance is approximately \$9000.00. The audit was successfully conducted. Dr. Worley expressed his appreciation for the opportunity to serve as treasurer and it was a great three years.

**Secretary's report – Ms. Christine Nix (UMHB)** – In regards to the SWACJ Constitution– the proposed changes were mailed to members in July. Additionally a form was available on-line to update the membership roster via the SWACJ gmail account. During the next year – members will receive update on SWACJ/ACJS items of interest via email.

**Journal editor report – The Southwest Journal of Criminal Justice – (Dr. David Montague** spoke on behalf of Dr. Roger Enriquez who could not attend the conference). Negotiations with Ebscohost (good research resources) for a contract without cost to SWACJ. The most recent edition of the journal would be posted to Ebscohost. This vehicle of online research would increase SWACJ's visibility. Additionally, Ebscohost would pay SWACJ for the number of hits received. The reimbursement could amount to a couple of hundred dollars per year and the reimbursement would be sent directly to the SWACJ treasurer. Dr. Helen Green asked if ACJS has been informed of the negotiation with Ebscohost. Dr. Will Oliver stated it was discussed and approved by ACJS.

**Webmaster report – Dr. Bill Stone** (Texas State University) discussed implementing a pay online credit card tool via PayPal. Dr. Montague stated numerous members had praised the efficiency and user friendly SWACJ website.

**Regional Trustee report – Dr. Willard M. Oliver** (SHSU) stated that a September meeting with ACJS was conducted in Baltimore, Maryland. A consulting group – Raben is lobbying for ACJS and ACS in regards to Senator Webb's crime bill. A presentation will be held in February 2011 in Toronto during the ACJS annual meeting regarding the lobbying efforts.

The Journal of Criminal Justice Education will be looking for an editor soon. If interested in this position, contact Will. ACJS online voting will begin fall 2010. A preliminary email has or will be sent for correct email address verification.

Both the ACJS and JCJE journals are going online. New members will automatically receive the online versions. Current members will have the option of paper or online. If membership dues are not paid- subsequent reinstatement will automatically result in the online subscription. Membership in ACJS is approximately 2500. SWACJ is in 4<sup>th</sup> place among the regional associations in numbers of members who are also members in ACJS. Approximately 1703 members attended the 2010 ACJS conference in San Diego. The 2011 ACJS annual conference will be held in Toronto, Canada from 1-5 March. A passport is a must.

The Experient group is assisting ACJS with the location of future conference sites. Due to the large number of rooms needed usually only one hotel in a city can provide accommodations and subsequently are in a position not to offer great room rates. ACJS is considering going to the same hotel in various cities of Baltimore, Denver, Orlando, and San Francisco.

Dr. Oliver stated he had been asked to research and write the history of ACJC in honor of the 50th anniversary in 2013. An ad hoc committee has been formed to decide upon a position of ACJS historian. In the 1970's a position for ACJS historian existed and then disappeared.

**New Business –Dr. David Montague** asked if there were any questions or comments. There were none. Dr. Montague invited past presidents to make remarks and none were made. Dr. Montague spoke in regards to the proposed constitutional changes from the 2009 business meeting in Laredo. The proposed revisions to the constitution were written by Drs. Eichenberg and Rubenser. The proposed changes were the different levels of membership for members and students in Section III and an amendment to Article III. Dr. Montague stated we, as members, should be better stewards of the Association and utilize electronic instead of postal mail for means of communication. The proposed changes were posted on the website and a letter informing members was mailed ninety days prior to the present meeting. Dr. Stone made a motion to accept the proposed changes and Ms. Katy Eichenberg made the second to the motion. A call for a vote was made and the motion carried with no opposition.

Dr. Montague discussed the open positions on the executive board and ad hoc committees. The position of treasurer was open since Dr. Worley rotated off after completing his three year term. The 2nd Vice President position was open and Dr. Montague informed the members present of Dr. Claudia San Miguel (Texas A & M International University) expressed interest in the position. Dr. Jeff Walker made the motion to nominate Dr. San Miguel for the position of 2<sup>nd</sup> VP and it was seconded by Dr. Oliver. Dr. Oliver made the motion to close the nominations and it was seconded by Dr. Walker and the vote carried. Dr. Montague called for nominations for the position of treasurer. Ms. Katy Eichenberg nominated Dr. Tom Jordan (Texas A&M University-Texarkana) and it was seconded by Dr. Will Oliver. With no other nominations made and a unanimous vote, Dr. Jordan was elected as the new SWACJ treasurer.

Dr. Montague informed the members present of Dr. Claudia San Miguel's long time active participation in SWACJ. Most recently Dr. San Miguel had worked closely with Dr. Bill Stone (SWACJ – Webmaster) to increase the visibility of SWACJ. Dr. Tom Jordan was thanked for his participation with the SWACJ audit committee. With his election to treasurer a vacancy existed on the audit committee. Members were instructed to contact Dr. George Eichenberg if interested in serving on the audit committee. George Day (SHSU) and Barbara Dimon expressed their interest in serving on the audit committee.

Dr. Montague presented a plaque of appreciation to Dr. Rob Worley for his hard work and dedication to SWACJ and as the treasurer from 2007 – 2010. Dr. Lorie Rubenser was presented a plaque of appreciation for her service as SWACJ secretary from 2007-2009.

Dr. Montague restated his appreciation to the members and the executive board for their support during his term as president. Dr. Montague officially turned the meeting over to Dr. George Eichenberg, the incoming 2011 SWACJ president.

**Incoming President – Dr. George Eichenberg** praised Dr. Montague and the UALR criminal justice department for their hard work in putting together an excellent conference. His first act of president was the presentation of a plaque of appreciation to Dr. Montague. A position of Past President was proposed by Dr. Eichenberg facilitate the transition from president to president.

A motion was made to adjourn, seconded, and voted upon without opposition.

### Regional Trustee's Report Will Oliver

This letter comes to you after both a successful mid-year business meeting for the Academy of Criminal Justice Sciences (ACJS) and annual meeting of the Southwest Association of Criminal Justice in Little Rock, Arkansas. The mid-year business meeting was held in Baltimore with a side trip to the national office and proved to be quite productive. Those of you who were in attendance in Little Rock I am sure will agree, it was an excellent conference. The Past Presidents' reception at the State House was quite an elegant affair, the food was phenomenal (best ribs I ever had), and the special display on Arkansas's criminal justice truly fit the theme. The panels, luncheon, guest speaker, hotel facilities and its location were all well received by those in attendance, and we especially appreciated the "hospitality room"! If you missed the Little Rock conference, start planning now for next year's conference when we head to College Station next September 29 through October 1, 2011 (see the President's report for more information).

In regard to events related to ACJS, we have an equally exciting conference coming up March 1-5, 2011, in Toronto, Canada. As several members of the SWACJ executive board will not be in attendance, I have agreed to run the general business meeting. If anyone has any business for the meeting or something you would like to share, please let me know before March. I do want to encourage you to try to attend the annual meeting in Toronto, just remember though, if you are planning to attend – make sure you have your passport.

While at the executive board meeting in Baltimore, we were visited by representatives of the Raben group who discussed the continued work between ASC and ACJS in order to make our organizations more visible in the public policy process. The Raben group has represented ACJS most recently before NIJ, OJP, and BJA, and there is continued work with Senator Webb who is trying to advance the passage of a crime bill that would create a new national commission on crime and criminal justice. Right now that bill is stalled in the Senate and with the recent elections is not likely to see passage this Congress. No doubt, Senator Webb will reintroduce the legislation come January with the opening of a new Congress.

We were also visited by Experient, a group that specializes in assisting large organizations like ourselves in obtaining the best conference locations suited to our needs for a reasonable price. As you all know, conferences and conference hotels are becoming more expensive. We are faced with somewhat of a dilemma due to growth in conference attendance. The past two years we have seen conference attendance exceed 1,700. In light of the number of panels and break out rooms necessary, many cities can no longer support us or, if they can, there

is a limited number of hotels that suit our needs – often only one. That creates a problem in terms of negotiating a fair price since the hotel more than likely knows they are the only host in town. Experient has been working to have chains compete with each other for our business by hosting us for the 2015, 2016, and 2017 conferences. They have come up with a short list of hotels for those three conferences and they are as follows (with the last year ACJS was in that city in parentheses): Baltimore, MD (2006), Denver, CO (1990), Kansas City, MO (1993), Orlando, FL (1999), and San Francisco, CA (1988). If you have any strong preference for any of these locations, please let me know before the ACJS conference in Toronto and I will bring it before the board.

ACJS is also now in the process of looking for a new editor for *The Journal of Criminal Justice Education*. The 2<sup>nd</sup> VP chairs the committee that makes a recommendation to the board, that is Craig Hemmens from Boise State University and I have been asked to serve on the board as well. If you would like to nominate anyone for this position or if you are considering applying for the position yourself, please let me know. The review process begins in January.

In addition, by now you all probably know, ACJS has gone to both on-line voting for our elections, as well as electronic journals (JQ, JCJE). If you are interested in continuing to receive the print copy of the journal you may do so, but you must indicate your desire and you must remain a member. Any new member after December 31, 2010, will only receive the electronic version. That means if you let your membership expire and you have to renew, you will lose your option to the print version.

Last Spring, at the business meeting in San Diego, CA, I was asked by the board to write the history of ACJS for the upcoming 50<sup>th</sup> anniversary of our parent organization. It is my intent to release the report at the annual meeting in 2013. I also requested that an ad hoc committee be formed at the mid-year meeting to explore bringing back to ACJS the board position of ACJS Historian. Our first, as far as I can tell, was Dr. Ed Ferris from New Mexico State University. I have formed my committee and will be delivering a report to the board at the business meeting in Toronto.

As always, if member has anything you would like me to bring before the ACJS executive board, please let me know at your earliest convenience.
